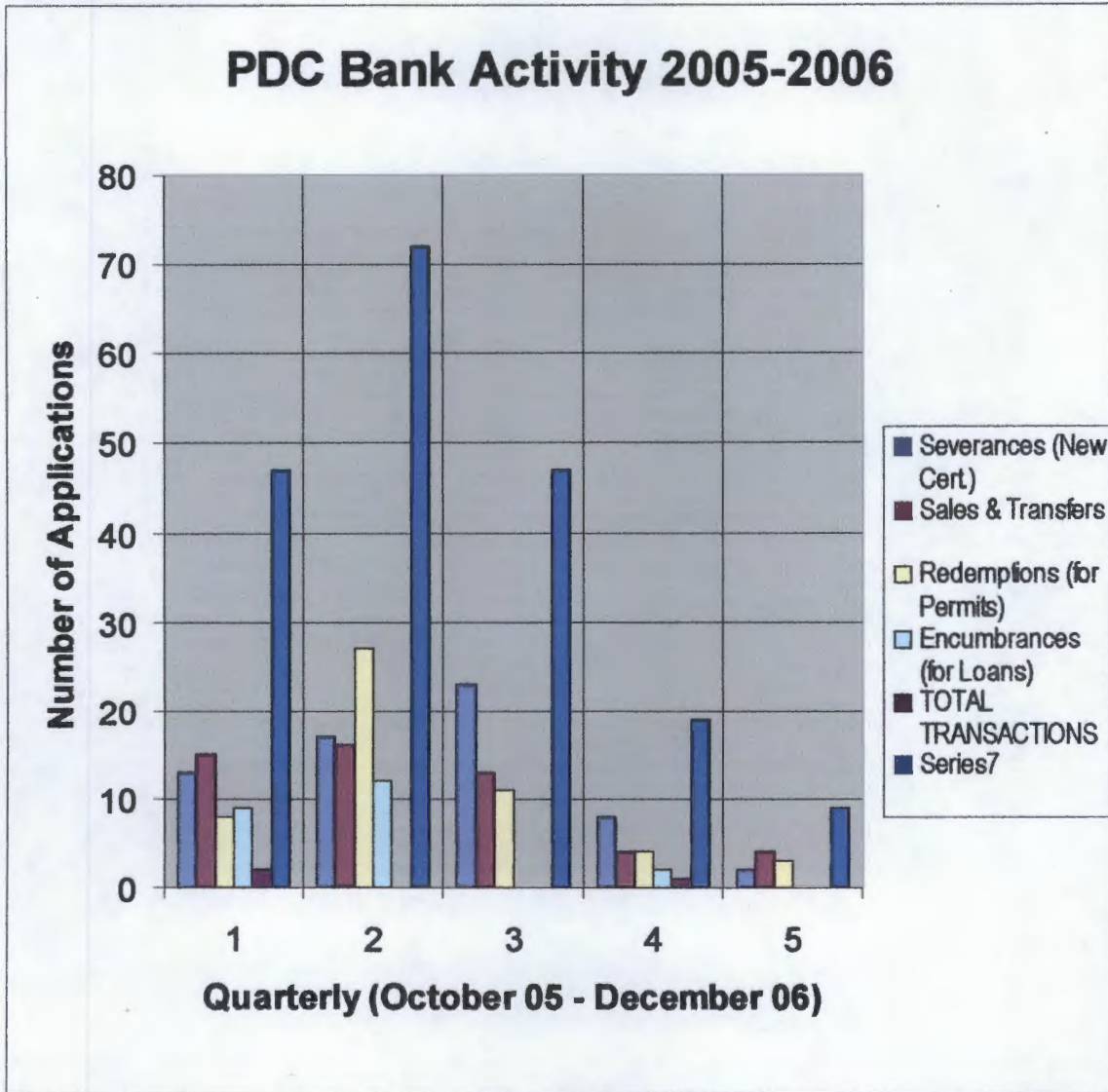
Executive Director's Report:

- Mr. Vivas reported that there are 1 sale, 2 redemptions and 16 severances for new credit applications under review.
- Mr. Vivas informed that the Pineland's network is shut down today because of a computer virus.
- For the period covering October 1 through December 31, 2006, the PDC Bank processed applications as indicated on the following chart distributed to the Board, using the chart to illustrate trends, such as the decline in activity (corresponding to recent trends in the real estate market).

- Mr. Vivas reported that he continues working on reviewing and editing all application related forms to be placed on the website in electronic format. The forms are in a downloadable format.
- Mr. Vivas announced that Nathan Johnson, Special Assistant to the Director of Banking, has been assigned to work in Pinelands by the Chairman McEwen. Mr. Vivas stated that Mr. Johnson is assigned for a 6 month probationary period. He also updated the board on Denise's progress by stating that she remains on extended leave which began in September of 2006. Chairperson McEwen added that Nathan Johnson's assignment was a temporary assignment and that a senior level assignment was made to help Mr. Vivas because of the difficulty in getting help for the Pinelands Credit Development Bank.
- Mr. Vivas reported that the new PDC Tracking computer system is nearing final completion. Large amounts of inconsistent data have been cleaned up and other quality control work is being completed.
- Mr. Vivas referenced the PDC Bank's outreach program. Now that a new staff person is on board, we will resume work on local mailings and "town meetings" to continue promoting the PDC program.
- Mr. Vivas informed the Board that the PDC Bank's relocation to the 5th floor has been completed.

Business of the Board:

- No activity was reported on the candidates to fill existing vacancies on the Board since the last Board meeting. An updated sketch of information on all candidates should be provided by the next meeting.
- Mr. Vivas reported that he is keeping track of market trends, and the most recent activity indicates that the PDC values may be gaining strength.


Other Business:
