**PVSC Holds Reorganization Meeting Virtually Again  
*Tucci and Quintana Re-Elected to Leadership Posts***

Newark, NJ – Commissioners Thomas Tucci, Jr., and Luis Quintana were re-elected Chairman and Vice Chairman, respectively, at the Passaic Valley Sewerage Commission’s (“PVSC”) Annual Reorganization Meeting earlier this month. In addition, Commissioner Mildred Crump was re-elected Board Secretary and Commissioner Elizabeth Calabrese was re-elected Board Treasurer. Matthew F. Murray was re-appointed as the Clerk to the Board of Commissioners.

Commissioners John J. Cosgrove, James Doran, Joseph Isola, Hector Lora and Brendan Murphy, as well as several members of the PVSC management team, were also present at the meeting. Commissioners Calabrese and Crump have served as commissioners since 2015, Commissioners Doran and Isola have served as commissioners since 2017, and Commissioners Cosgrove, Lora and Murphy have served as commissioners since 2019.

This was the second straight year that the Reorganization Meeting was held virtually. All large internal and external meetings have been held virtually since the beginning of the COVID-19 pandemic.
