Calendar Year 2023 PVSC Permit Compliance Awards Recipients

Newark, NJ – The Passaic Valley Sewerage Commission ("PVSC") recently honored 112 of its permittees that operated in the previous calendar year without having incurred a single effluent (wastewater discharge) or reporting violation. PVSC has now recognized perfect environmental compliance records for 29 consecutive years.

PVSC issues Sewer Use Permits, or Liquid Waste Acceptance Permits (for hauled wastes), to Significant Industrial Users discharging to its Newark treatment works. These Permits include limits for the quality of effluent the companies may discharge into the sewer system. These entities must also monitor and report on their discharges to PVSC on a monthly basis. Compliance violations typically occur when a company exceeds its permitted discharge limits, neglects to take requisite samples, or fails to file its monthly report on time.

Each facility that goes a full calendar year without a single violation earns a PVSC Permit Compliance Award. Sika Corporation of Lyndhurst has garnered the honor for 27 consecutive years. Other multi-year honorees include Anheuser-Busch of Newark (18), Royal Wine Corporation of Bayonne (16), A&B Famous Gefilte Fish of Paterson and WY Industries of North Bergen (12 apiece), and Brown Chemical of Paterson and Monmouth County Reclamation Center in Tinton Falls (10 apiece).

"These award winners constantly adhere to strict discharge limits," said PVSC Chairman Thomas Tucci, Jr. "To go an entire year without a single violation demonstrates conscientiousness and an ongoing mission to operate in an environmentally responsible way. I congratulate these companies for their commitment to protecting the public health. We are very pleased to honor each of them in this way."
