### **About the Commission:**

The New Jersey State Commission of Investigation ("SCI") is an independent, bipartisan agency created to investigate organized crime, public corruption, waste, fraud, and abuse in government. Our work often leads to legislative reform, regulatory improvements, and enhanced public accountability. We conduct thorough, nonpartisan investigations and issue public reports to inform policymakers and the public.

### **Position Overview:**

The SCI is seeking a highly qualified candidate for the position of Investigative Counsel to plan, develop, organize and supervise fact-finding investigations. These investigations include organized crime and racketeering, the conduct of public officials and employees and any other matters concerning the public peace, safety and justice.

### **Key Responsibilities:**

- Plan and execute investigations into organized crime, government misconduct, and waste, fraud or abuse
- Conduct legal research and analyze relevant statutes, regulations, and case law
- Draft subpoenas
- Interview witnesses and prepare witness summaries
- Provide legal guidance to investigative staff
- Assist in preparing public reports, including developing well-reasoned recommendations for policymakers and stakeholders

Qualified candidates will possess a minimum of three years as a practicing attorney, preferably in prosecutorial work in law enforcement and/or in the conduct of complex civil or other types of fact-finding investigations. Thorough knowledge of state and federal law and practices. Exceptional writing and communications skills. Demonstrated ability to handle multiple assignments simultaneously. Experience in supervising professional and

other staff, including investigators, in performing assigned duties and in meeting program goals.

This position is based in Trenton, NJ, with the opportunity for a hybrid work arrangement.
