Whats New?

On August 9th, members of the commission were invited to join an American Indian and Alaska Native Veteran Suicide Prevention talking circle. The focus of the meeting was on how to raise awareness to challenges faced by AI/AN veterans and discuss strategies for healing and suicide prevention. The group discussed available resources both through the VA and non-VA organizations. There was discussion of the possibility of having an event... "Fall Fest" possibly on tribal grounds. Their next meeting is tentatively scheduled for September.

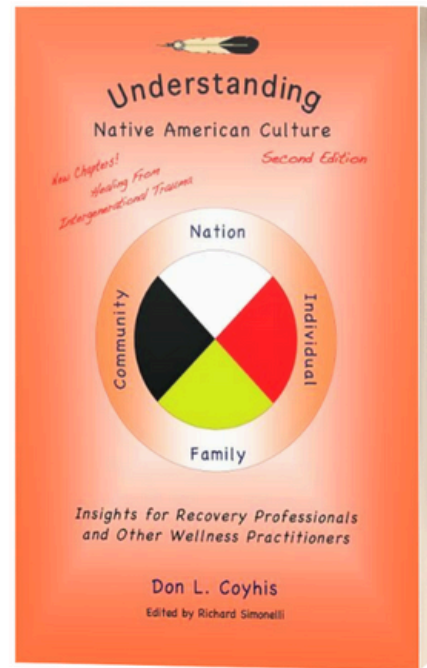
