The New Jersey State Commission and our AmeriCorps partners mourn the loss of our dedicated Chairman, Mike Pulsinelli. Mike was the Chairman of the New Jersey Commission on National and Community Service for over ten years. He was a great proponent of public service and volunteerism and worked to strengthen and expand the mission of the Commission Board. Mike supported the Commission by attending every AmeriCorps and Volunteerism event, and was always two hours early!

Mike grew up in Washington, NJ and was a graduate of Warren Hills High School Class of 1977. In 1980 Mike began his career as an Apprentice with Local 581 International Brotherhood of Electrical Workers (IBEW). He completed a four year apprenticeship and performed on numerous jobs as journeyman, foreman and shop steward.

Mike also served on the IBEW Local Union 581 Executive Board. In 1993 Local 102, 367 and 581 merged and Mike served on the Pension and Annuity Fund as Trustee for 10 years and continued to be an active participant on the Committee as a Business Agent. Mike also served on the Joint Apprentice and Training Committee for 10 years and was still active. He was the head of the Safety Committee for Local 102 and a certified OSHA 5600 Trainer, 40 Hour Hazardous Waste, United States Department of Labor National Mine Health & Safety Trainer, and a representative for New Jersey State Safety Council Expo. Mike truly loved his job and union labor.

Above all he loved his family and friends. He adored his children and grandchildren and treasured every moment spent with them. He has touched many lives and will be greatly missed by all who knew him.

The New Jersey AmeriCorps Commission Staff Offered Multiple Trainings



Our Staff at the State Commission was very busy in September and October. We offered multiple in-person trainings for our Program Directors, program Support staff and members.

We started off in September, to kick off the new program year, with a training for all Program Directors. We call this training "Starting Stronger". This was a follow up event to the "Starting Strong" that was offered in August. We dove deeper into topics related to running a successful AmeriCorps Program.

The topics included "Building Resilient Communities", by Kayann Foster, Certified ACES Trainer, "Data Quality and Collection Methods" by our partners at Montclair State University, "The Process and Outreach for Medicaid Renewal" by Carol Grant, Department of Human Services.

Our staff rounded out the day with trainings on best practices for Program Directors", AmeriCorps Terms and Conditions, as well as the many AmeriCorps Regulations and FAQ.
