## **January 22**

**Last Day for Testing of Electronic Scanning Equipment for Tabulation of Paper Ballots for January Special School Board Election**

*(A county board of elections may begin opening the inner envelopes for each mail-in ballot and canvassing each mail-in ballot from the inner envelope no earlier than five days prior to the day of the election-January 27)*

*(notice to be given 48 hours prior to the start of testing)*

*(no later than 144 hours (6 days) after the time of the closing of the polls for the election)*

**Deadline for Receipt of Cure Form to County Boards of Election**

*(no later than 48 hours (2 days) prior to the final certification of the results of the election)*

*(15 days after the election)*
