AUDIT OF ELECTION RESULTS

2020 GENERAL ELECTION

Audit Date: December 10, 2020

In accordance with N.J.S.A. 19:61-9c (5), the Essex County Board of Election divided all Vote by Mail and Provisional Ballots into "batches/audit units" and then sorted by Congressional Districts. Two percent (2%) of the number of batches in each of Essex County Congressional District (CD 7, 8, 10 & 11) were randomly selected to audit. Our audit consisted of a total of seventy-six (76) batches; 7th CD..2 batches, 8th CD..9 batches, 10th CD..38 batches, and 11th CD..27 batches.

In each batch, a hand to eye audit was completed. Fifty-four (54) batches were 100% consistent with the Election Summary Report. Attached is a complete breakdown of the Audit results which explains any missed and/or inaccurate tallies.
