N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

2021 General Election
Audit Date: November 20, 2021

The Cumberland County Board of Elections (BOE herein) performed an audit consistent with the provisions of N.J.S.A. 19:61-9 and the New Jersey Election Audit Procedures developed by the New Jersey State Division of Elections (See attached).

The Cumberland County BOE conducted a hand-to-eye count of the voter-verifiable paper records for the General Election for all state offices, legislative district offices as well as county and municipal offices selected by the Secretary of State. The offices to be audited are that of the Governor & Lieutenant Governor, State Senator, General Assembly, County Commissioners, City Council, City Commissioners, Township Committee, and Borough Council (if applicable) as directed by the Division of Elections and Secretary of State Tahesha Way. All other offices were excluded from the audit.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts."

There were 316 audit units for Legislative District 1 & 80 audit units for Legislative District 3. Two percent (2%) of 316 for Legislative District 1 batches indicated that six (6) batches were required to be audited. Two percent (2%) of 80 for Legislative District 3 batches indicated that two (2) batches were required to be audited. A total of eight (8) batches were required to be audited.

The following audit units were randomly selected:

1. RED BAG MLV 5-1 City of Millville – Legislative District 1
2. RED BAG MLV 5-5 City of Millville – Legislative District 1
3. RED BAG VLD 3-1 City of Vineland – Legislative District 1
4. TUB 3 Batch 180 Hopewell Township – Legislative District 1
5. TUB 4 Batch 28 Shiloh Borough – Legislative District 1
6. TUB 2 Batch 19 Greenwich Township – Legislative District 1
7. TUB 9 Batch 1 City of Bridgeton – Legislative District 3
8. TUB 1 Batch 5 City of Bridgeton – Legislative District 3

In each district, the hand to eye audit was consistent with the scanned tally. Where it was inconsistent the attached spreadsheet indicates the number change, if any. Where a zero is added the audit is consistent with the scanned report. Any paper ballot which contained an overvote for a particular contest was recorded as an overvote, but did

not count a vote. While the audit did tally undervotes, a post audit review by a bipartisan team reconciled undervotes in a more deliberate and consistent manner and were added to the attached report.
