N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

2024 General Election

Audit Date: November 25th and 26th 2024

The Atlantic County Board of Elections (BOE herein) performed a post-election audit consistent with the provisions of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Monday, November 25th, and Tuesday, November 26th. The BOE conducted a hand-to-eye count of the voter-verifiable paper records for the November 5, 2024, General Election for the offices of the Unites States President, United States Senate, United States House of Representatives, Atlantic County Commissioner-at-Large, and local mayor and/or council contests. In accordance with the law, Public Questions, School Board, and Fire District elections were not audited.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." The guidelines provided for this audit require 2% of the audit units in each of the congressional districts to be randomly selected. The County of Atlantic contains only 1 such district (2nd Congressional District). Audit units included: early voting, election day, vote by mail, and provisional ballots.

The following 28 audit units/batches were randomly selected:

All hand tallies matched the machine counts except 1.) Provisional C0005-Machine 1, 2.) Election Day 49 EHT D-5, and 3.) Election Day 64 EHT D-20, which had slight discrepancies of +1 or -1 vote. The audit did not result in any significant change in the number of votes counted for any candidate.
