## N.J.S.A. 19:61-9 AUDITS OF ELECTION RESULTS

## 2024 GENERAL ELECTION

Audit Date: November 18, 19, 20, 2024

The Mercer County Board of Elections (MC BOE) performed an audit consistent with the provisions of N.J.S.A. 19:61-9.

The General Election held November 5, 2024 was conducted with Nine (9) days of early voting using the Dominion ICX Ballot Marking Devices and ICP2 Tabulators w/ paper ballots, Vote-By Mail Ballots, and Provisional Ballots. The Dominion ICP2 w/ paper ballots on Election Day. (for Audit Only)

The MC BOE conducted a hand-to-eye count of the paper records for the General Election held November 5, 2024 for the following offices:

Audit units were comprised of early voting ballots, election day machine ballots, vote-by-mail ballots, and provisional ballots. Pursuant to the statute, 2 Units of the paper ballot batches for Early Voting within Mercer County were to be audited.

The following batches were randomly selected for the audit:

### **Congressional 3rd**

2 mail in ballots batches were selected: East Windsor = Batch 7 ICC03 and Robbinsville Batch 54 – ICC02 Machine Ballots – Election Day Tabulators – East Windsor 402, Lawrence, 556 and 560

### Congressional 12<sup>th</sup>

5 - Mail in Ballots – Hopewell Boro – Batch 11 ICC04, Princeton Batch 81, ICC05, Princeton 82 – ICC05, Princeton Batch 84- ICC07 and Trenton North Batch 40 ICC04

Machine Ballots Election Day Tabulators – Trenton North – Tabulator 600, West Windsor Tabulator 642 Early Voting Tabulators #115 and #130

Provisional Batches - Hamilton - Batch 63 ICC07, Trenton South, Batch 68 ICC07

Early Voting – ICP 130 – after 3 hand to eye count 1 vote for County Commissioner Terrence Stokes was off by one vote.

The remainder of the Hand to Eye Count were 100% Accurate.
