# N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

November 5, 2024 General Election Audit Date: November 18, 2024

The Union County Board of Elections (UCBOE) performed a post-election audit consistent with the provisions of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Monday, November 18, 2024. The audit was available to the public via zoom and in-person observation.

The UCBOE conducted a hand-to-eye count of the voter-verifiable paper records created during the course of administering the November 5, 2024 General Election for the offices of President, United States Senate, United States House of Representatives, County Commissioner and Municipal Mayor or Council / Township Committee. Public Questions and Boards of Education elections were excluded from the audit.

Pursuant to the statute, the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot. The guidelines provided for this audit require 2% of the audit units in each of the congressional districts to be randomly selected. The audit batches were selected on Sunday, November 17, 2024 and the process was available to the public via zoom.

Audit units included voter verified paper audit trails from each voting machine used in Early Voting and on Election Day, mail-in ballots; and provisional ballots tabulated on the ES&S DS850. In total, 852 audit units were created.

There are four congressional districts in Union County: the 7th, 8th, 10th and 12th. In the 7th CD, there are a total of 368 batches. Eight audit batches were randomly selected. In the 8st CD, there are a total of 110 batches. Three audit batches were randomly selected. In the 10th CD, there are a total of 317 batches. Seven audit batches were randomly selected. In the 12th CD, there are a total of 57batches. Two audit batches were randomly selected.

As provided for in the statute, the following audit units were randomly selected for audit on Sunday, November 17, 2024 at 9:00am via a publicly advertised and accessible zoom meeting:

In each district, the hand to eye audit was 100% consistent with the machine tally. The audit did not result in a change in the number of votes counted for any candidate. The voting machines do not allow for overvotes. Any paper ballot which contained an overvote for a particular contest recorded it as an overvote, but did not count a vote. Undervotes were recorded by the vote tabulation system and were reconciled during the course of the audit.
