N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS
November 4, 2025 General Election and Audit Date: November 17, 2025

The Burlington County Board of Elections performed a post-election audit consistent with the provisions of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Monday, November 17, 2025. The audit was open to the public and our Board was present.

The Burlington County Board of Elections conducted a hand-to-eye count for the November 4, 2025 General Election for the offices of the Governor, General Assembly, Sheriff, and Municipal Mayor or Council/Committee in all batches selected. In accordance with the law, Public Questions, School Elections, and Fire District Elections were not audited.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." The guidelines provided for this audit require 2% of the audit units in each of the congressional districts to be randomly selected. Audit units included: election day, early voting ballots, vote-by-mail ballots, and provisional ballots. In total, 671 audit units were created.

There are four Legislative Districts in Burlington County: 6th, 7th, 8th, and 12th. There were 53 audit units for the 6th Legislative Congressional District, and 2 batches were audited. There were 165 audit units for the 7th Legislative District, and 4 batches were audited. There were 431 audit units for the 8th Legislative Congressional District and 9 batches were audited. There were 22 audit units for the 12th Legislative District and 2 batches were audited.
