The Council was established to encourage and foster public interest in the arts, enlarge public and private resources devoted to the arts, promote freedom of expression in the arts, and facilitate the inclusion of art in every public building in New Jersey. The Council believes the arts are central to every element we value most in a modern society including: human understanding, cultural and civic pride, strong communities, excellent schools, lifelong learning, creative expression, and economic opportunity.



State support for the arts comes from the Hotel/Motel Occupancy Fee, a renewable revenue source the arts industry helps to generate, as well as a partnership grant from the National Endowment for the Arts. With a combined \$33,545,200, a record 957 grants and customized services reached all 21 counties in support of NJ communities, families, and individuals.

Operating Grants

Multiyear, flexible support to help nonprofit arts organizations pay for basic operations.

Local Arts Program

New Jersey's network of 21 County Arts Agencies (CAAs) extended the reach of and access to Council dollars. CAAs support local arts development programs and regrant funds to community-based organizations and projects.

Arts Projects

Based on changing needs in the field, new and renewed programs focused on arts education, healthy aging, professional development, cultural access, public art, economic development, and more.

Individual Artists

Individual Artist Fellowships provided means to sustain and strengthen the careers of artists at the heart of our state's creative industries. The inaugural Heritage Fellowships recognized artistic excellence, lifetime achievement, and contributions to New Jersey's traditional arts heritage.

Public art meets New Jersey's residents where they are – in their neighborhoods, transit stations, even on crosswalks on their streets. These interventions bring art to people in their daily lives, and through strategic partnerships and collaborations, communities are able to see themselves represented in locally made works. A key priority for the Council's public art projects is to open doors for more artists from a greater diversity of backgrounds.

168 artists participated in Making It Public, a free, multiweek professional development series designed to support artists of all disciplines in exploring their art making practice and expanding into public spaces.

85 administrators representing nonprofits, local and regional arts councils, arts and entertainment districts, and units of government participated in Making It Public, which provided resources to help strengthen local capacity for public art.
