
# **Diversity, Equity, Access, & Inclusion**

# FY23 Grants Snapshot

With another year of historic state funding for Fiscal Year 2023, the State Arts Council focused on strategic grantmaking and customized services to support our state's essential arts industry. The Council's responsive programs are aligned with the State of New Jersey's commitment to equitable, inclusive public service, centered on increasing quality of life for people of all ages.





As the largest funder of the arts in New Jersey, the majority of the Council's FY23 grants provided multi-year, flexible support to help organizations pay for basic operations in service to their missions.

# **FY23 Grants Snapshot**

#### **Operating**

Multi-year, flexible support to helped nonprofit arts organizations pay for basic operations. Unrestricted operating grants are often the most difficult to obtain by arts organizations.

#### **Arts Projects**

Cultural Access Network, Arts Annuals, State of the Arts, Folklife Centers, NJ Arts & Culture Administrators of Color, Critical Financial Services, Artists in Education Residency Grant Program, Arts Professional Learning Institute, Capital Arts-History, Special Initiative Grants, ArtsPay NJ, Creative Aging Initiative.

#### **Local Arts Program**

New Jersey's network of 21 County Arts Agencies (CAAs) extended the reach of and access to Council dollars. CAAs support local arts development programs and regrant funds to community-based organizations and projects.

#### **Individual Artists**

Folk Arts Apprenticeships supported the preservation and celebration of valued artistic and cultural traditions. Individual Artist Fellowships strengthened the careers of a historic number of NJ artists.





95% of FY23 funds provided grants to serve communities, families, and individuals in all 21 counties.



Increased funding for individual artists by 27.4%.



\$7,989,735 investment in South Jersey counties.



The Arts Council provided 901 grants serving all 21 counties.

## **New this Year**

In FY23, the Council supported a host of new programs and services in direct response to grantees and constituent feedback.

#### **Creative Aging Initiative**

\$220.000

A new grant program designed to support lifelong learning in the arts for older adults. Eligible organizations included arts organizations, libraries, veterans homes, and senior and community centers.



50% of CAI's 22 grantees were new to the Council's roster.

#### **Capital Arts - Historic Locations**

\$2.6 million+

A first-ever collaborative grant program between the Council and the New Jersey Historic Trust, designed to assist nonprofit arts organizations operating within historic locations.



The Capital Arts program awarded 13 grants.

**ArtsPay NJ** \$10,000

ArtsPay NJ is a long-term project to build pay equity. Data captured in the first year of the project will provide a baseline of understanding about pay levels, reveal areas of inequities, and provide the information necessary to proactively address inequities.



The project is driven by: Arts Ed NJ, ArtPride New Jersey, Dance New Jersey, New Jersey Theatre Alliance, New Jersey Association of Museums, and South Jersey Cultural Alliance.

#### **Teaching Artist Speed Networking**

This event was created by the Council in partnership with the members of the Arts Education Community of Practice. Teaching artists met with arts organizations looking to engage with and hire teaching artists.



166 teaching artists and 16 arts organizations participated.

#### **Making it Public**

In partnership with Forecast Public Art, the Council hosted two, free, five-week virtual workshops focused on supporting public art in communities throughout New Jersey.



317 individuals were engaged - a record number of participants!


