CHAIR'S COMMENTS

Chair McKenna introduced to everyone the new Executive Director Donna Rendeiro, Chair McKenna commented that had the pleasure of working with Mrs. Rendeiro in the past in the Office of Smart Growth. Also, that Mrs. Rendeiro is been involved with the State Planning in many different functions over the years.

Executive Director Rendeiro thanked everyone for the opportunity particularly the Governor, The Lieutenant Governor, the Secretary of State, Melanie Willoughby and to the Chairman for the opportunity.

NEW BUSINESS

Resolution No. 2019-07 Authorizing Memorandum & Extending Village Center Millstone, Somerset County

Chair McKenna asked Mr. Ableman if he had any comments. Mr. Ableman commented that the State Planning Commission adopted a Resolution that created a center for two years on 2006 the Center was extended. Also, that the Center is currently expired. Millstone is been working to vote on the Center Plan Endorsement and on addressing a lot of the flooding, the Municipalities have been trying to deal with both litigation leading to affordable housing as well as purchasing properties from the County and the Municipality. Mr. Ableman made a point that in the Action Plan within the Resolution, there is a statement about Millstone working with OPA and DEP to essentially look at the Center and figure out what makes more sense on terms of follow the configuration of the Center boundary.

Chair McKenna expressed his agreement with M. Ableman.

Chair McKenna asked for questions or comments from the Commission members or the public.

PUBLIC COMMENT

Mr. Walt Lane, Director of Planning from Somerset County, thanked to all the State Agencies and expressed on behalf on the Borough and the County been very excited that all is moving forward for the Center designation. Therefore Mr. Lane requested a wording change on the resolution where it says "reviewed and revised" to "potentially revise".

Chairman McKenna noted that the change was not necessary, explained that the way it was worded doesn't meant that it has to be revise it, DEP is going to be sensitive to work with Somerset County as well as with Millstone and our office. Chairman McKenna expressed that with all the respect the word change was not really necessary. Mr. Lane expressed their concern to set a precedent for a future. Chairman McKenna reinforced on behalf of the Commission on having faith in DEP to work with the County and Millstone.

Chair McKenna asked for questions or comments.

Chair McKenna asked for a motion on Resolution No. 2019-07, Commissioner Fiordaliso made the motion and it was seconded by Commissioner Hsueh.

Resolution No. 2019-08 Authorizing an Amendment to the State Plan Policy Map in Princeton, Mercer County

Chair McKenna asked Mr. Ableman if he had any comments. Mr. Ableman commented that at the Public Hearing held in Princeton the property owner of Block 901, Lot 18 said that the Lot was merged with the adjoining Lot 17. Mr. Ableman commented that the Office of Planning Advocacy recommends that the two lots are now known as Block 901, Lot 22 be considered as part of the map amendment. Also, that the project on affordable housing will provide a 100% affordable unit development.

Chair McKenna asked for questions or comments from the Commission members or the public.

Chair McKenna asked for a motion on Resolution No. 2019-08, Commissioner Hsueh made the motion and it was seconded by Commissioner Fiordaliso.
