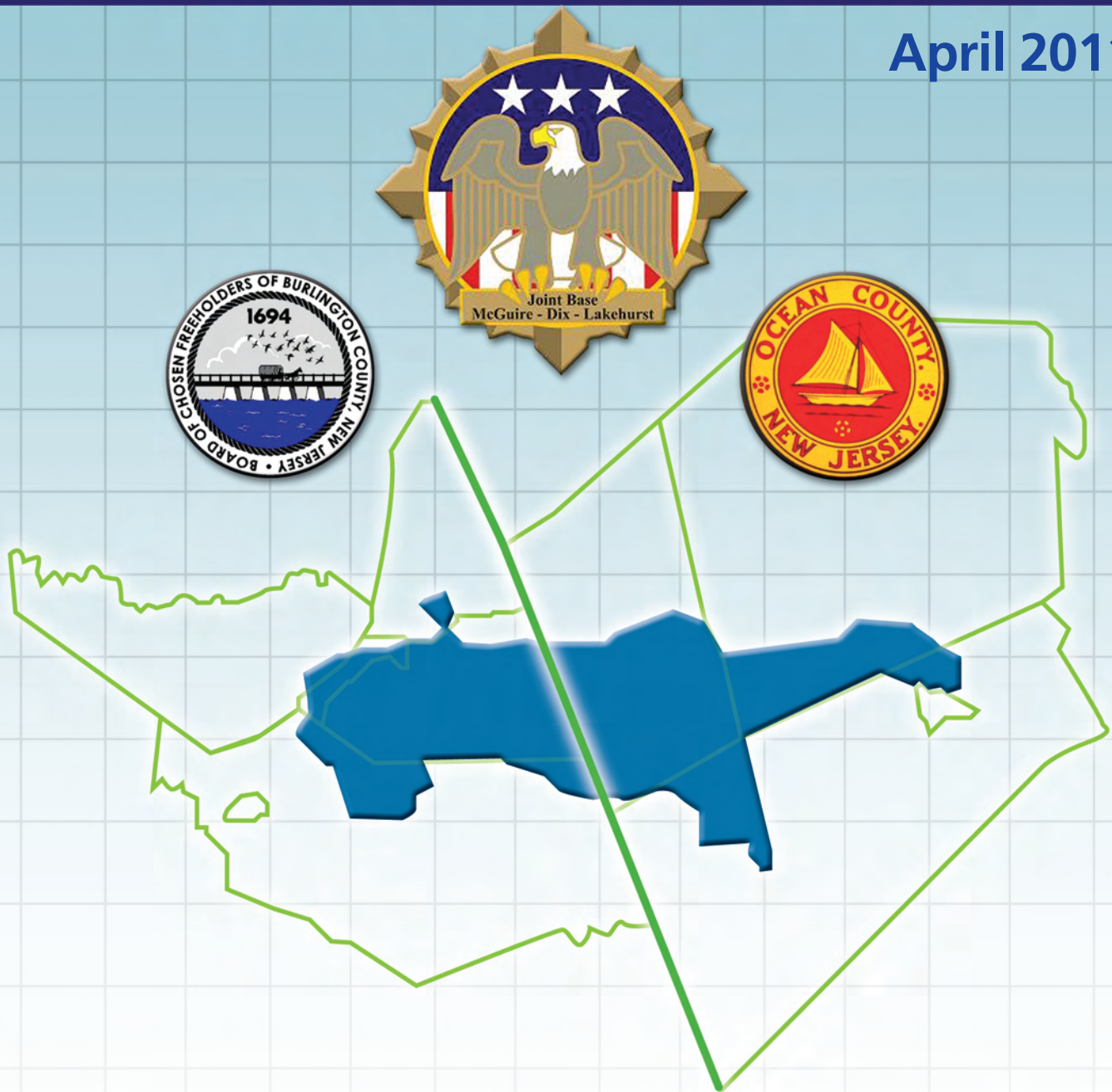

Introduction

The three individual installations of McGuire Air Force Base, Fort Dix, and Lakehurst Naval Air Engineering Station combined to form the nation's first tri-service joint base on October 1, 2009.

The new Joint Base McGuire-Dix-Lakehurst (JB MDL) is the result of that union, a 42,000-acre cantonment area that supports more than 22,000 jobs in Ocean and Burlington County, NJ.

In 2009, the counties of Ocean and Burlington completed a Joint Land Use Study (JLUS), which offered 45 recommendations to ensure sustainable regional development in the ten municipalities surrounding JB MDL, that are compatible with existing and future Joint Base missions. This Communication Coordination Manual (CCM) is the implementation of one of those JLUS recommendations. One key JLUS challenge was the need for greater coordination and communication among the civil local government and Joint Base. This CCM provides contact information for all JLUS stakeholders on:

1. Public policy issues related to the administration of a municipality or the military installation, with specific emphasis on land use and quality of life issues.
2. The “who, what, where and how” issues associated with communication between the Joint Base McGuire-Dix-Lakehurst and its surrounding civilian communities.

Simply put, the purpose of this manual is to:

1. Enhance relationships among community leaders and the Joint Base command and support staff that transcend periodic changes in command and local leadership.
2. Sustain conservation, development, and redevelopment efforts, both on and off base that are compatible with Joint Base mission requirements.

HOW TO USE THIS CCM

We have designed this CCM to build and enhance the personal relationships that support effective communication and coordination across the military fence. This CCM contains contact information for the elected / appointed / ranking administrator for various “official” positions at Joint Base, the two host counties and ten municipalities. It also identifies the appropriate department or office, telephone number and email contact information for the regional land use and the quality of life-oriented issues identified in the 2009 JLUS.

We provided this manual with direct telephone lines, extensions and email addresses to enable military and civilian peers to contact each other more readily. For some issues, such as military / veterans affairs, public assistance, public health and transit / transportation, we often list a county office contact because a few rural municipalities are too small to handle these issues on their own. In other cases, the municipal contact may be a state agency, private contractor, or another municipality with a shared-service contact.

As these relationships change, often due to changes in local elected leadership or Joint Base command, subsequent leaders should use information contained herein as a way to build new relationships that are critical for effective regionalism.

Use this manual often. Get to know your regional partners and neighbors. It will help you achieve the successful, sustainable development of the region that we all share and preservation of the Joint Base’s critical missions.

DEVELOPING THE CCM

Work on the CCM formally began on July 29, 2009 when the Joint Base Commander and the mission support staff gathered with local municipal and county leaders at the McGuire Club on Joint Base. For many, this was the first time they had met one another. This was also the first time they had all convened to discuss ways to implement the recently completed Joint Land Use Study (JLUS) and to coordinate on issues of sustainable growth and development. Attendees discussed the futures of their jurisdiction and the region, as well as communication practices and strategies that had, and had not, worked well in the past. They shared their visions for future collaboration and communication on the specific land use and quality of life issues outlined in the JLUS recommendations.

The military and civilian representatives identified several key challenges to regional coordination and communication, including:

- The need to build strong, confident relationships by improving communication among military-civilian peers on issues of mutual interest.
- The need to understand how organizations are structured, which positions hold which responsibilities / authorities, and which are the appropriate offices / staff levels to contact for given issues.
- The need for a process that focuses on stable administrative positions and not individuals, which periodically change by command re-assignment or election cycle.

JLUS stakeholders agreed that they needed to learn from each other, over time, the most effective ways to communicate with each other, such as by peer-to-peer meeting, letter, memo, telephone call, facsimile, email, etc., about a variety of issues. They also recognized that different communication methods depended on differing circumstances and issue priorities. The stakeholders learned that Joint Base and local emergency management officials had developed a communication manual of contacts and procedures to train for and respond to potential crisis and disaster situations. The stakeholders needed a similar pro-active communications and procedures system for non-emergency situations. This new system would allow them to plan for and coordinate regional land use and quality of life-oriented issues, such as, economic development, housing, agriculture, education, recreation, public health, solid waste and wastewater management, and transportation.

They agreed that their first step to better communication and coordination was to develop a Joint Base area manual with contact information pages for Joint Base and each municipal and county government. The manual would list the name, title, telephone number and email address for each elected / appointed / ranking administrator for various “official” positions. It would also include the appropriate department or office, telephone number, and email contact information for the variety of regional land use and quality of life issues identified in the JLUS. They agreed to rely on telephone, facsimile, and email, when available, for informal and everyday matters, and with letters and memos for formal matters. As their relationships matured, they would explore using Joint Base JLUS website and other communication systems to share additional information, such as local and regional land use plans and JLUS project status reports.

UPDATING THE CCM

The JLUS stakeholders know that the publication of the first CCM is just the beginning of a long-term communication and coordination commitment. Not only will they need to update it annually, but also they must improve the quality of the information that it contains. We expect each annual CCM edition to be as good as the last one, or better. Equally important, points of contacts will need to train their successors to allow for a smooth transition in our deepening military-civilian relationships.

Introduction

LOCAL GOVERNMENT IN NEW JERSEY

Over its 345-year history, New Jersey has evolved into a unique local government structure that can be confusing to people, both inside and outside its borders. One of the purposes of this document is to help service personnel understand which local civilian public agency is responsible for handling the various civilian public policy issues that periodically arise during their assignment at Joint Base McGuire-Dix-Lakehurst. New Jersey has two levels of local government, county and municipal, and each has separate functions. Joint Base stretches across two counties, Burlington and Ocean, and ten separate incorporated municipalities abut or are within two miles of the base. Six municipalities: New Hanover Township, North Hanover Township, Pemberton Borough, Pemberton Township, Springfield Township and Wrightstown Borough, are in Burlington County. Four municipalities: Jackson Township, Lakehurst Borough, Manchester Township and Plumsted Township—are in Ocean County. The text on the following pages outlines how local governments operate and which local officials or offices are responsible for its administration.

Each of New Jersey's 566 municipalities is independent of the others. Each has its own elections, mayors and local governments, laws and ordinances, property tax levies, land use approval agencies, public works departments, etc. Although there are different forms of municipal government, such as cities, boroughs and townships, all municipalities have the same basic powers and authorities. Municipal governing bodies also range in size from three to seven or more elected officials. Every municipality has a mayor as its chief representative, but a mayor's roles, responsibilities and election process, vary by statute. Some mayors are chief executives, independent of the elected legislative governing body, but many are not. Local statutes may call a municipal governing body a council, committee, commission or something else. Some municipalities hire a business administrator or manager to supervise municipal government operations. Others rely on the municipal clerk to handle day-to-day affairs.

Every municipality has a clerk, who is responsible for maintaining all legal documents and is the principal point of contact (POC) for the municipality. If the municipal POC or the issue contact is unavailable, call the main county switchboard for guidance. Burlington County (609) 265-5000 or Ocean County (732) 224-2121.

Rural municipalities, and those with small populations, may not offer some local services, such as public libraries, water and sewer systems, and curbside trash removal, that more developed suburban and urban municipalities do. This is because their residents and businesses do not believe they need them or do not want to tax themselves to pay for them. Municipalities, however, often find other ways to provide those services. For example, they may rely on or contract with a state or county agency for a public service, such as the State Police or a County library system. They also may share services, such as trash removal or road repair, with another municipality or may hire a private contractor to do this work. Most municipalities hire private engineering and legal firms for professional services.

New Jersey's 21 counties provide traditional court-related functions, such as recording land titles (deeds), recording wills and adjudicating estates, prosecuting state laws, providing a sheriff and officers to administer state courts, and maintaining the jail. County residents elect a "board of chosen freeholders" as the county's governing body. This term dates to the early nineteenth century when only property owners, or freeholders, could vote or hold office. They also have state-authorized boards that provide countywide public services for general health, welfare, education and safety. These services include affordable housing, public assistance, senior citizens, solid waste management, emergency management, regional highways and parks, farmland preservation, community colleges and libraries, etc. Depending on their size and population, municipalities may also provide some of these services to their residents, independent of or in conjunction with the County. The text on the following pages in this manual help to explain how Joint Base's ten host municipalities and two counties work together to make our community a desirable place to live, work, play, and serve the Country.

CIVILIAN COMMUNICATIONS PROCEDURES

The Municipal Land Use Law (N.J.S.A. 40:55D-1 et seq.) regulates land use planning and development procedures in New Jersey. This law gives municipalities responsibility for adopting master plans and zoning ordinances and for approving development applications. Master Plans and their component elements provide a municipality's vision for its future development character and the public policies needed to achieve that vision. Zoning ordinances, which must be consistent with the master plan, regulate the types of land uses and structures permitted in certain districts, or zones, defined by the municipality. The ordinances specify standards, such as intensity of use, lot size, setbacks, parking requirements, etc., that developments must meet to receive municipal approval. Because counties have little control over land use planning and development approvals, the primary contact point is at the municipal level.

The law contains procedures for plan and ordinance amendments, land development approvals, and public notice requirements. Municipal zoning officers ensure that development applications are consistent with ordinance requirements. They determine whether the application requires a hearing at the municipal land use / planning board or the zoning board of adjustment, if the applicant requires a use variance. The municipal land use / planning board secretary or the zoning board secretary, schedules the hearing and distributes information to the appropriate board members. Applicants are required to notify property owners, within 200 feet of the property, about the hearing at least 10 days in advance of the hearing. The zoning officer may also approve the application such as for a one or two-family home, fence or agricultural structure, without a hearing. All developments require approval from the municipal construction code officer, who issues construction permits and certificates of occupancy. The municipal land use / planning board secretary also notifies the public at least 10 days in advance of a scheduled hearing to consider amendments to the master plan or the zoning ordinance.

Pursuant to N.J.S.A. 40:55D-12.4, the Joint Base commander has registered with each of the JLUS study area's municipal zoning officers. The commander has requested the Base's Community Planning and Liaison Officer (CPLO) receive public notices from the municipal land use / planning board and zoning board secretaries for all board hearings on the following actions that may affect property within 3,000 feet of the facility:

- Adoption or amendments to a municipal master plan or of its component elements;
- Adoption of a master plan re-examination report;
- Adoption or amendments to a municipal land use or zoning ordinance;
- Adoption or amendments to a redevelopment plan;
- Review of the municipal Capital Improvement Plan; and
- Review of the municipal Official Map.

These board secretaries shall also provide development applicants with the CPLO's contact information so that the applicants will send the CPLO public notices for all board hearings on the following actions that may affect property within 3,000 feet of the facility

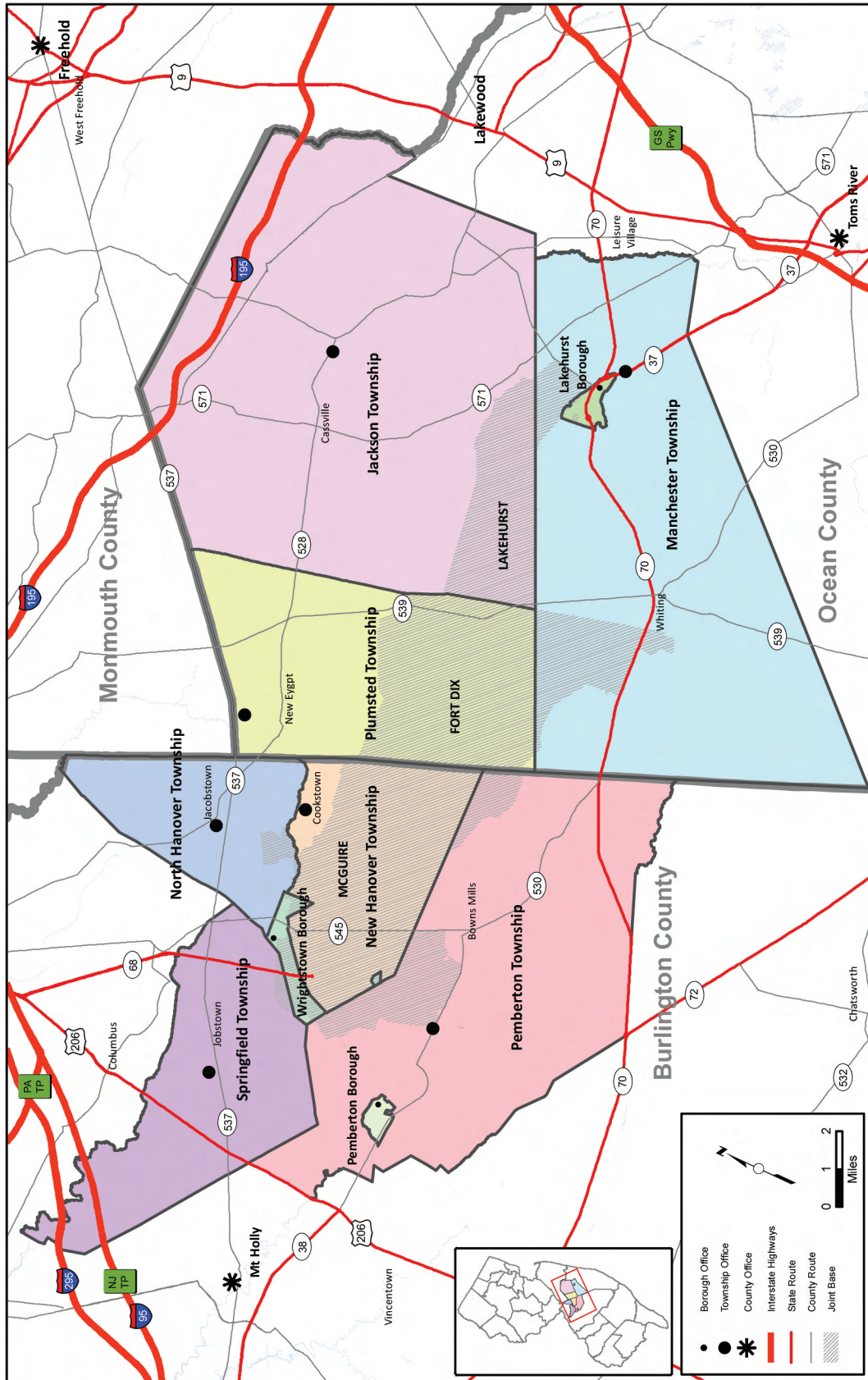
- Development applications requiring board approval; and
- Erection of outdoor advertising signs.

Although not required under the Municipal Land Use Law, municipal zoning officers shall provide Joint Base's Community Planning and Liaison Officer a copy of:

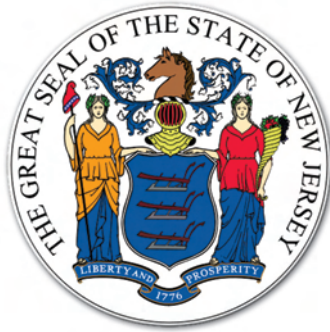
- All Zoning Permit applications for property within 3,000 feet of the facility; and
- Zoning Board of Adjustment Annual Reports, required by N.J.S.A. 40:55D-70.1.

Representatives from Joint Base shall have the opportunity to attend and participate in public meetings and hearings and to provide verbal and/or written input.

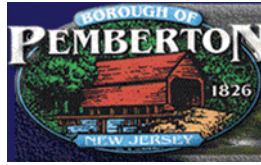

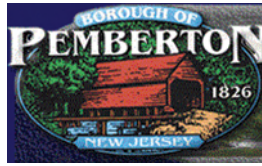
