THE PROPOSED PROJECT

The purpose of this project is to improve the safety and operation of the signalized intersection of Route 15 and Berkshire Valley Road/CR 699 in Jefferson Township, Morris County. The NJDOT is realigning and widening Berkshire Valley Road to improve the geometry and to accommodate a five-lane section between Route 15 northbound and southbound. This new five-lane section will include a dual left turn lane from Berkshire Valley Road southbound to Route 15 southbound. Additional improvements include widening and extending the Route 15 northbound outside through lane; the construction of sidewalks in compliance with the Americans with Disabilities Act (ADA); the complete replacement of the traffic

signals; and upgrades to the existing stormwater conveyance system and guiderail.

CONSTRUCTION STAGING

Construction will be completed in three primary stages utilizing daily lane closures during daytime off-peak and overnight hours. The existing lane configuration and operation of the intersections will be maintained during peak AM and PM travel times to limit congestion and delays. Ramp construction will only occur overnight and with a ramp detour in place. Access to businesses and residences will be maintained.

Stage 1 includes the relocation of impacted utilities and construction of the proposed traffic signal system. Roadway improvements including drainage, concrete curb and sidewalks, driveways, and pavement widening will be constructed along both directions of Route 15 and along Berkshire Valley Road southbound.

Stage 2 will include construction of drainage, concrete curb and sidewalks, driveways, and pavement along both directions of Route 15 and along Berkshire Valley Road northbound.

Stage 3 will include final paving of the roadways and the final configuration of the traffic control devices.
