JOB DESCRIPTION

The New Jersey Department of Treasury, Division of Revenue and Enterprise Services (DORES) is seeking an Administrative Analyst 3, Information Systems for the Application Development Unit. The incumbent will confer with department/agency personnel to analyze current operational procedures, business rules and practices; determines feasibility for automation, identifies problems or areas for improvements, and develops solutions; Studies existing information processing systems to evaluate their efficiency and effectiveness; determines specific system requirements; performs system and application needs analysis; Analyzes information, processes and/or statistical and operating reports to detect work backlogs and system problems; Recommends and/or reviews recommendations for enhancements or new systems, application software, or services to improve production or workflow and to meet current and projected business needs; Takes the lead and/or participates in the gathering and development of business and user requirements, including participating in Joint Application Design (JAD) sessions; Prepares and/or reviews various standard and ad hoc reports for business units and IT. May be required to perform other related duties as deemed necessary.

The standard workweek is Monday through Friday. This position <u>may</u> be eligible to participate in the Department's pilot telework program, which allows eligible employees to work remotely for up to two (2) days per week, as approved by management. The position offers a comprehensive benefits package including medical, prescription drug, and dental coverage, benefit leave, Pension, supplemental pension plan, tax saving programs, and paid holidays.

POSITION REQUIREMENTS

Education & Experience:

Seven (7) years of professional experience in work involving the review, analysis, and evaluation of the administrative, business, and/or operational policies, procedures, practices, and processes and/or the technological requirements of an organization for the purpose of revising/enhancing existing information systems and/or developing/acquiring and implementing new IT solutions and services.

-OR-

Possession of a bachelor's degree from an accredited college or university; and three (3) years of the above-mentioned professional experience.

-OR-

Possession of a master's degree in Public Administration, Business Administration, Computer Science, Information Technology, Software Engineering, Information Security, Network Administration, or Database Management; and two (2) years of the above-mentioned professional experience.

Note: Applicants must meet one of the following or a combination of both experience and

education. Thirty (30) semester hour credits are equal to one (1) year of relevant

experience.

Note: "Professional experience" refers to work that is analytical, evaluative, and interpretive; requires a range of basic knowledge of the profession's concepts and practices; and is

performed with the authority to act and make accurate and informed decisions.
