**RESOLUTION**

**Regarding County Alliance Plan Funding for January 1 – June 30, 2014**

**September 17, 2013**

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse (GCADA), the Alliance to Prevent Alcoholism and Drug Abuse Program and the Drug Enforcement Demand Reduction Fund (DEDR) were established pursuant to N.J.S.A. 26:2BB-1 and N.J.S.A. 2C:35-15; and,

WHEREAS, the GCADA has the statutory authority to adopt regulatory rules and policies for the administration and governance of the Alliance to Prevent Alcoholism and Drug Abuse Program; and,

WHEREAS, the GCADA also has the statutory authority to adopt a funding formula in order to disperse funds to said Program from the DEDR; and,

WHEREAS, the 2013 grant term has been extended for six months from January 1, 2014 to June 30, 2014, and henceforth the Alliance grant cycle will coincide with the fiscal rather than calendar year.

NOW THEREFORE BE IT RESOLVED, that the GCADA approves the following County Alliance Grant Awards for the extension period of January 1, 2014 to June 30, 2014, subject to executing a Letter of Agreement, Grant Agreement and Attachments A, B and C that shall detail County compliance with reporting, monitoring, evaluation and auditing procedures to ensure that only allowable expenditures are funded and which may be amended during the term of the Award:
