



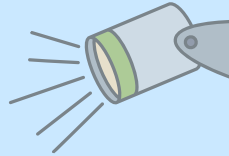

FY24 AmeriCorps State and National Competitive Grants

Funding Agency: AmeriCorps

Purpose: To fund eligible organizations that engage AmeriCorps members in evidence-based or evidence-informed interventions to strengthen communities.

Eligibility: State, city, township, special district, and county governments, nonprofits that do and do not have a 501(c)(3) status with the IRS, public, state, and private institutions of higher education, Native American organizations and tribal governments, others.

Deadline: 1/23/25

FY 2025 Notice of Funding Opportunity: Bipartisan Infrastructure Law (BIL) FAA Contract Tower (FCT) Competitive Grant Program

Funding Agency: Department of Transportation

Purpose: To make annual grants available to eligible airports for airport-owned airport traffic control tower (ATCT) projects that address the aging infrastructure of the nation's airports.

Eligibility: State, city, township, special district, and county governments, others.
Funding: Awards up to \$20,000,000

Deadline: 9/18/24

Service Area Competition

Funding Agency: Department of Health and Human Services

Purpose: To ensure continuity of care in the communities and populations currently served by the Health Center Program.

Eligibility: State, city, township, special district, and county governments, nonprofits that do and do not have a 501(c)(3) status with the IRS, public, state, and private institutions of higher education, independent school districts, Native American organizations and tribal governments, others.

Teaching with Primary Sources – Regional Awards

Funding Agency: Library of Congress

Purpose: To provide instructional materials, tools, education, and professional development that enhance teachers' ability to integrate digitized primary sources from the Library of Congress into instruction that builds student literacy, critical thinking skills, content knowledge and ability to conduct original research.

Eligibility: State, city, township, special district, and county governments, nonprofits that do and do not have a 501(c)(3) status with the IRS, public, state, and private institutions of higher education, independent school districts, small businesses, for profit organizations, Native American organizations and tribal governments, others.

Funding: Awards up to \$900,000

Deadline: 10/2/24

National Digital Newspaper Program

Funding Agency: National Endowment for the Humanities

Purpose: This program creates a national digital resource of historically significant newspapers published between 1690 and 1963 from all 56 states and U.S. jurisdictions.

Eligibility: State, special district, county, city, and township governments, public, state, and private institutions of higher education, Native American tribal governments, nonprofits that have a 501(c)(3) status with the IRS.

Funding: \$2,500,000; awards up to \$325,000

Deadline: 1/10/25

NIJ FY24 Evaluation of BJA Byrne State Crisis Intervention Program (SCIP): Scan of Practices and Evaluability Assessments

Funding Agency: Department of Justice

Purpose: To provide funding for the implementation and/or creation of specific program areas: (1) extreme risk protection order (ERPO) programs, (2) courts response to people in crisis, (3) community-based services for people in crisis, and (4) funding for law enforcement crisis intervention programs or initiatives.

Eligibility: State, city, township, special district, and county governments, nonprofits that do and do not have a 501(c)(3) status with the IRS, public, state, and private institutions of higher education, Native American organizations and tribal governments, small businesses, public/Indian housing authorities, for profit organizations, others

Funding: \$6,600,000; awards up to \$1,500,000

Deadline: 11/19/24
