JOB DESCRIPTION

The State of New Jersey, Department of the Treasury seeks Personnel Assistant 3 in the Division of Administration, Office of Human Resources within the Employment Unit. The New Jersey Department of the Treasury’s Office of Human Resources is responsible for providing Human Resources services and support to employees and management, which consists of an approximate 3300 employees across thirteen core Divisions and numerous In but Not of Agencies (IBNO). We offer a full range of personnel services including organizational planning, classification, compensation, recruitment, hiring, promotions, employee development, performance appraisal, training, payroll, timekeeping, leave administration, and employee/labor relations.

Staff within the Employment Unit are responsible for the development, issuance and distribution of job vacancy postings; development and placement of employment advertisements; review of candidate submissions for eligibility; scheduling candidates for interviews; providing prospective employees with information regarding general conditions of employment and applicable merit system rules; making employment offers and preparing employment offer letters; the preparation of new hire sign-up packages; conducting new hire sign up ensuring that new employees are provided with necessary information and documentation regarding their employment including state and departmental policies, leave entitlements, health, dental and prescription drug coverage, and pension enrollment; the review and verification of employment related documents and forms; conducting large-scale recruitment efforts, and issuing State ID Cards. Will be assigned other related special projects.

The standard workweek is Monday through Friday. This position **may** be eligible to participate in the Department’s pilot telework program, which allows eligible employees to work remotely for up to two (2) days per week, as approved by management. The position offers a comprehensive benefits package including medical, prescription drug, and dental coverage, benefit leave, Pension, supplemental pension plan, tax saving programs, and paid holidays.

POSITION REQUIREMENTS

Open to the following: Open to full-time employees who have permanent status in a competitive title and who meet the requirements listed below. Appointments will be made in accordance with Civil Services rules and regulations and may result in a forfeiture of rights to any promotional lists in the former office/unit.

Requirements: Applicants must meet one of the above or a combination of both experience and education. **Thirty (30) semester hour credits are equal to one (1) year of relevant experience.**

Six (6) years of professional experience in a personnel program of a public or private organization.

OR

Possession of a bachelor’s degree from an accredited college or university; and two (2) years of the above-mentioned professional experience.

OR

Possession of a master’s degree in business administration, personnel administration, public administration, management, or other related field from an accredited college or university; and one (1) year of above mentioned professional experience.

Note: “Professional experience” refers to work that is creative, analytical, evaluative, and interpretive; requires a range of depth of specialized knowledge of profession’s principles, concepts, theories, and practices; and is performed with the authority to act accordingly to one’s own judgement and make accurate and informed decisions.
