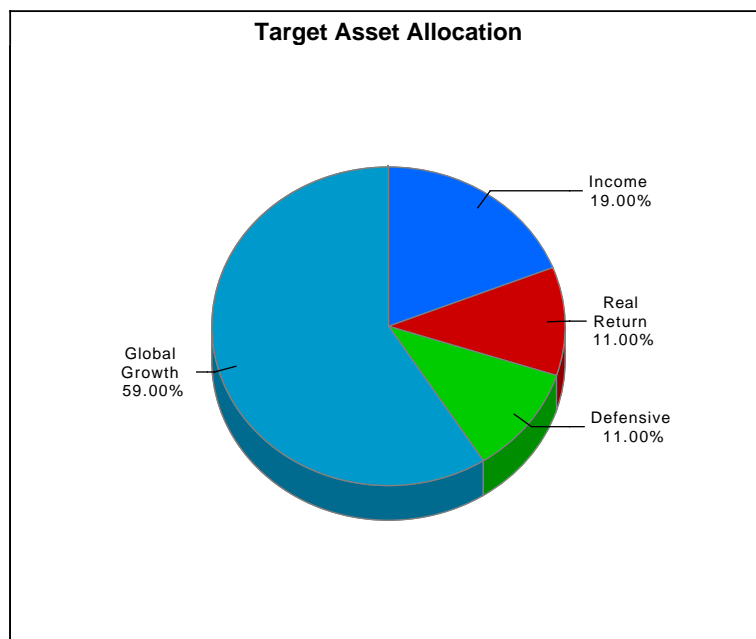
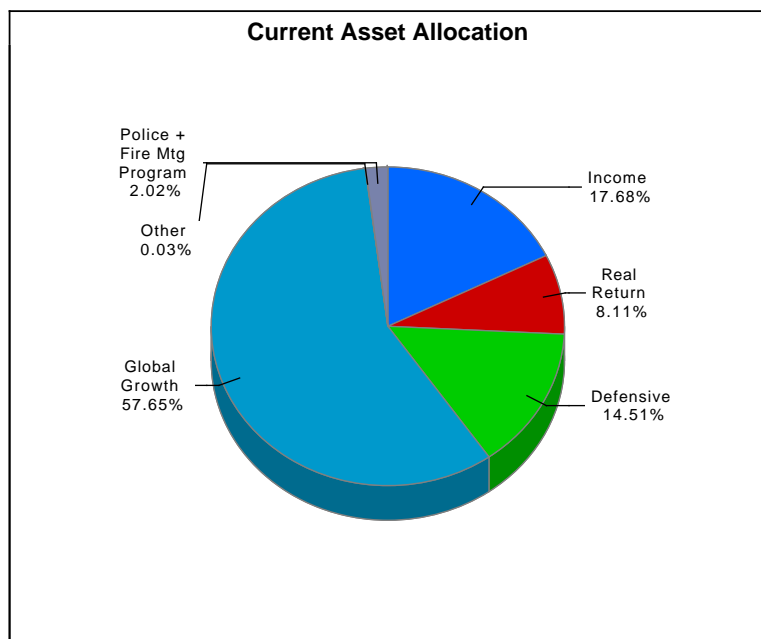

As of August 31, 2023**

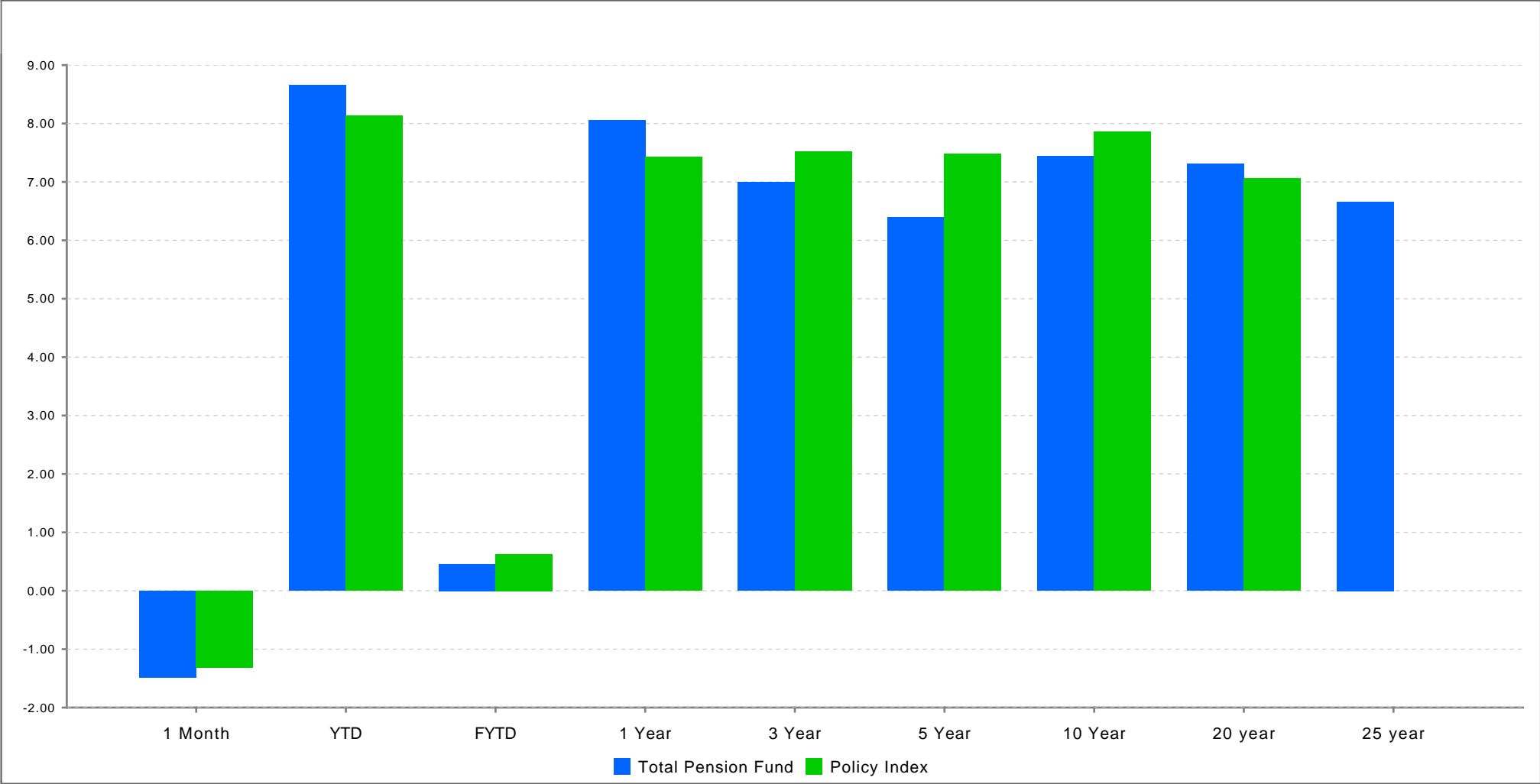

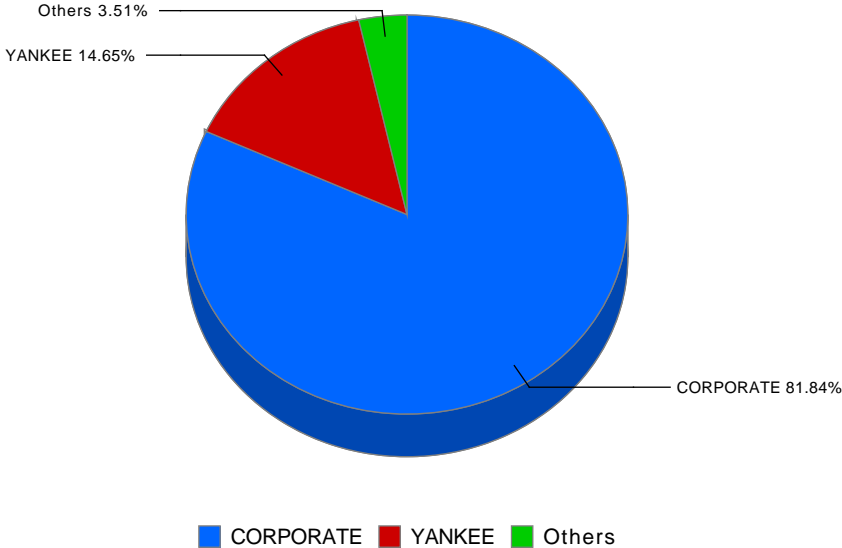
