# New Jersey Division of Taxation ANCHOR Program Request for ID/PIN or NJ Gross Income

## ID/PIN

Use this form only if you were a homeowner on October 1, 2019 and you need your ID and PIN to complete your ANCHOR application. **Renters/Tenants do not need an ID or PIN to file the ANCHOR application.**

## Gross Income

If you filed a 2019 New Jersey Resident Income Tax Return, but do not have the gross income amount to complete your ANCHOR application, use this form to request a figure to enter on your application.

**You must include a copy of your government-issued photo ID with the form. We will not respond to incomplete requests. Acceptable file formats: PDF, JPEG, JPG, PNG, TIFF, or TIF.**

## How to Send Your Request

### By Email

Send an email to [docrequest.tax@treas.nj.gov](mailto:docrequest.tax@treas.nj.gov) and attach the completed form **and** a copy of your government-issued photo ID. In the Subject line, enter “**ANCHOR Program Request for ID/PIN or NJ Gross Income,**” your last name, and first initial. Once we receive your request we will respond by email to address provided above.

### By Fax

Fax the completed form and a copy of your government-issued photo ID to (609) 292-0147. On the cover page, include “ANCHOR Program Request for ID/PIN or NJ Gross Income” along with your last name and first initial.

## How We Respond and What We Will Provide

Once we receive your request, we will respond by email to the address provided above.

We will provide you with either an ID/PIN or an amount to report as the New Jersey gross income on your ANCHOR application. The amount we provide **will not** be the gross income amount reported on your 2019 New Jersey Income Tax return since we cannot provide that amount for security purposes, but it will allow you to complete your application.

You must include a daytime phone number in case we have any questions regarding your request.
