Subject: Upcoming Changes to Services

Dear Patient,

We hope this letter finds you in good health.

We are writing to inform you about important changes to the services you receive from Sanitas Medical Center of New Jersey, PC ("Sanitas"). As of September 28, 2024, all Sanitas Medical Center locations in New Jersey will be under the management of RWJ Barnabas Health Medical Group ("RWJBH").

Sanitas's affiliation with the New Jersey State Health Benefits Program and School Employees' Health Benefits Program (the "SHBP DPC Program") will end on September 27, 2024. This is applicable to both adult and pediatric services. As a result, the advantages that you currently receive through the SHBP DPC Program will no longer be available at our locations. We understand the impact this decision may have on you and your healthcare needs.

The practice will join RWJBH and continue to provide services to Horizon Blue Cross Blue Shield of New Jersey ("Horizon") members. **As a Horizon member, you may continue seeing your current provider at the same location with applicable cost-sharing or consider utilizing an alternate DPC provider found at <https://www.nj.gov/treasury/pensions/dpcmh.shtml>.**

In accordance with the SHBP DPC Program's membership agreement, we are providing you with this notice at least 30 days before the termination of the SHBP DPC Program. This is to ensure you have ample time to consider any necessary transitions for the continuity of your care.

Our goal is to make this a seamless transition with no interruption to your care. If you choose to stay with your provider, you do not need to take any action concerning your medical records. Should you choose to transfer your care to a different provider and require a copy of your medical records prior to September 28, 2024, please call your provider's office for assistance at the phone number listed in the enclosed Provider Contact Directory. If you require a copy of your medical records after September 28, 2024, please complete this [authorization](#)¹ or call the office for assistance.
