IOB DESCRIPTION

The New Jersey Cannabis Regulatory Commission is seeking a Technical Assistant 2 within the Office of Compliance and Investigations. Under the direction of the Director of the Office of Compliance and Investigations or its designee, reviews programmatic documents or other documents for accuracy, appropriateness, and completeness. Identifies and resolves problems related to the processing of documents in accordance with the rules, regulations, and laws of the NJ- CRC. Edits, updates, verifies, and corrects data related to the submitted compliance and investigation documents submitted. Exercise collaborative judgement with Supervisor in order to correct all errors. Contacts applicants and business owners to verify information and resolve problem situations and complaint. Prepares correspondence designed to convey information concerning the regulations and procedures as they pertain to the work of the Compliance and Investigations unit. Maintains logs of assignments and establishes tracking system for better work flow. Maintains essential records and files. Assists in providing statistical data and information pertaining to the work of the unit. May provide procedural information, obligations, responsibilities and rights to program participants and interested parties.

The standard workweek is Monday through Friday. This position <u>may</u> be eligible to participate in the Department's pilot telework program, which allows eligible employees to work remotely for up to two (2) days per week, as approved by management. The position offers a comprehensive benefits package including medical, prescription drug, and dental coverage, benefit leave, Pension, supplemental pension plan, tax saving programs, and paid holidays.
