V. PROJECT STATUS REPORTING

Vice Chairman Mullen asked Mr. Faraca to provide a project update on the current projects.

Mr. Faraca stated that the NJBA has a lot of projects moving forward right now, most important one right now going on is the Executive State House.

The majority of the Executive State House staff is moved into the building. We just have some issues around the portico which for the new members, everybody else understood that we have we had an issue with some cracking and the portico which is the front overhang on the building, we're working through it with the insurance company and the design team. We just came to a resolution of how to make the how to do the repair and we just started moving forward, moving that over to the contractor for some pricing. We pre purchased generators for the executive statehouse which are long lead items. Two are for business continuity and one for emergency power. The design for this work is close to being completed. However, the generators are a long lead item scheduled for delivery one year from now. We are proceeding with the installation design.

The Capitol Complex Security Screening Building and Secure Courtyard Project, which is going in between the Annex and Executive State House and the courtyard. Work actually just started on the project yesterday, August 7, 2023. We are still waiting for some documents to come back from DCA, however, they are tying in the sewer for this building, as we speak.

There are two Justice Juvenile Complex buildings. We are going to be starting one in Ewing and one in Winslow Township, where we have the construction manager and the design team on board and we're moving forward with the design on those two projects

We also have out to bid for selection of construction manager, for an addition to the health lab building, which we built about 15 years ago. There are also a number of small projects going on throughout the state that we are working on with the Division of Property Management & Construction. We have quite a few projects in progress.
