ORDINANCE OF THE CITY OF ATLANTIC CITY REPEALING ORDINANCE NO. 11 OF 2011

WHEREAS, the governing body of the City of Atlantic City, County of Atlantic, on February 23, 2011 adopted Ordinance No. 11 of 2011 titled "AN ORDINANCE ESTABLISHING THAT A BUSINESS ENTITY WHICH MAKES POLITICAL CONTRIBUTIONS TO MUNICIPAL CANDIDATES AND MUNICIPAL AND COUNTY POLITICAL PARTIES IN EXCESS OF CERTAIN THRESHOLDS SHALL BE LIMITED IN ITS ABILITY TO RECEIVE PUBLIC CONTRACTS FROM THE CITY OF ATLANTIC CITY"; and

WHEREAS, the City does not believe that the goals underlying Ordinance No. 11 of 2011 have been achieved since its implementation; and

WHEREAS, the State of New Jersey, through its Legislature, has adopted the New Jersey Campaign Contribution and Expenditures Reporting Act, Codified at N.J.S.A. 19:44A-1 et seq., which contains restriction which are different from the restrictions contained in Ordinance No. 11 of 2011; and

WHEREAS, the State of New Jersey Statutes, as Codified in <u>N.J.S.A.</u> 19:44A-1, <u>et seq.</u>, include provisions that require certain contracts previously exempt from competitive requirements to be awarded pursuant to a "fair and open process"; and

WHEREAS, N.J.S.A. 19:44A-20.5 establishes the standards by which business entities contracting with municipalities may be awarded a contract.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Atlantic City that Atlantic City Ordinance No. 11 of 2011, as Codified in City Code Chapter 206, adopted February 23, 2011, shall be and is hereby repealed and shall have no effect whatsoever as of the effective date of this Ordinance. Ordinance No. 11 of 2011 is rescinded and the City of Atlantic City shall adhere to the State standards as Codified in N.J.S.A. 19:44A-1, et seq.

Section 1. A copy of this Ordinance shall be filed by the City Clerk to the Secretary of State, State of New Jersey.

Section 2. Any Ordinance or parts of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed to the extent to such inconsistency.

Section 3. This Ordinance shall become effective following adoption and publication as required by law.
