*(on or before 12 noon on Wednesday preceding the January 24, 2023 municipal non-partisan run-off election)*  
*(Consistent with requirements prior to the implementation of early voting which does not apply to run-off elections)*

### January 19-23

**Testing of Electronic Scanning Equipment for Tabulation of Paper Ballots for the January 24, 2023 Municipal Non-Partisan Run-off Election**  
*(date to be determined by County Board of Elections with 48 hour notice)*

### January 20

**Deadline for Application to Receive Mail-In Ballots by Electronic Means for Qualified Overseas Civilian and Military Voters for the January 24, 2023 Municipal Non-Partisan Run-off Election**  
*(4th day before election)*

### January 23 – by 3:00 p.m.

**Deadline for In-Person Mail-In Ballot Applications for January 24, 2023 Municipal Non-Partisan Run-off Election**  
*(up to 3:00 p.m. on the day before election)*

## Trenton Municipal Non-Partisan Run-off Election Timeline For At-Large Council Seats

### January 24 - February 10

#### Impoundment Period for Voting Machines Used in the January 24, 2023 Non-Partisan Municipal Run-off Election

*(17 days following the closure and locking of the voting machines to comply with P.L. 2018, c.72, )*  
N.J.S.A. 19:52-6

### January 26

#### Deadline for Receipt by County Boards of Elections of Mail-In Ballots for January 24, 2023 Municipal Non-Partisan Run-off Election by delivery of the United States Postal Service that DO NOT Bear a Postmark of Delivery

*(no later than 48 hours (2 days) after the time of the closing of the polls for the election)*  
N.J.S.A. 19:63-22

### January 30

#### Deadline for Receipt of Timely Mailed Postmarked Mail-In Ballots for January 24, 2023 Municipal Non-Partisan Run-off Election to County Boards of Election

*(no later than 144 hours (6 days) after the time of the closing of the polls for the election)*  
N.J.S.A. 19:63-22

### January 31

#### Deadline for Receipt of Cure Form to County Boards of Election for January 24, 2023 Municipal Non-Partisan Run-off Election

*(no later than 48 hours (2 days) prior to the final certification of the results of the election)*  
N.J.S.A. 19:63-17b(2)

## February, 2023

### February 2

#### Canvass by Municipal Clerk of Votes Cast in January 24, 2023 Municipal Non-Partisan Run-off Election

*(to comply with P.L. 2020, c.71; N.J.S.A. 19:63-22; N.J.S.A. 40:45-16)*

### February 8

#### Deadline for Preparation of Emergency and Provisional Ballot Reports for January 24, 2023 Municipal Non-Partisan Run-off Election by County Board of Election

*(within 15 days after election or 3 days after the certification of the results of the election, whichever is later)*  
N.J.S.A. 19:53B-21; N.J.S.A. 19:53C-21

### February 10

#### Deadline for Applications for Recheck of Voting Machines Used in January 24, 2023 Municipal Non-Partisan Run-off Election

*(within 17 days after election to comply with P.L. 2018, c.72)*
