(on or before 12 noon on Wednesday preceding election)

(Consistent with requirements prior to the implementation of early voting which does not apply to school elections)

December 5

Last Day for Testing of Electronic Scanning Equipment for Tabulation of Paper Ballots for December Special School Board Election

(A county board of elections may begin opening the inner envelopes for each mail-in ballot and canvassing each mail-in ballot from the inner envelope no earlier than five days prior to the day of the election-December 5)

(notice to be given 48 hours prior to the start of testing)

(no later than 48 hours (2 days) after the time of the closing of the polls for the election)

Deadline for Receipt of Timely Mailed Postmarked Mail-In Ballots to County Boards of Election

(no later than 144 hours (6 days) after the time of the closing of the polls for the election)
