# 2025 Annual School Board Election Timeline

## April 10

### **Last Day for Testing of Electronic Scanning Equipment for Tabulation of Paper Ballots for Annual School Board Elections**

*(A county board of elections may begin opening the inner envelopes for each mail-in ballot and canvassing each mail-in ballot from the inner envelope no earlier than five days prior to the day of the election-March 12)*

*(notice to be given 48 hours prior to the start of testing)*

### **Deadline for Application to Receive Annual School Board Election Mail-In Ballots by Electronic Means for Qualified Overseas Civilian and Military Voters**

*(4th day before election)*

### **Deadline for Receipt of Cure Form to County Boards of Election**

*(no later than 48 hours (2 days) prior to the final certification of the results of the election)*

*(15 days after the election)*
