N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

November 3, 2020 General Election Audit Date: December 1, 2020

The Burlington County Board of Elections performed a post-election audit consistent with the provisions of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Tuesday, December 1, 2020. The audit was available to the public via zoom and livestream.

The Burlington County Board of Elections conducted a hand-to-eye count of the voter-verifiable paper records for the November 3, 2020 General Election for the offices of the United States President, United States Senate, United States House of Representatives, Burlington County Freeholder and Mayor. Council and Board of Education elections were excluded from the audit, as were public questions.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." Due to the COVID-19 global pandemic, this election was conducted as a primarily paper election. The guidelines provided for this audit require 2% of the audit units in each of the congressional districts to be randomly selected. Audit units included: vote by mail ballots by municipality / ward; and provisional ballots by municipality / ward. In total, 2,842 audit units were created.

There are three congressional districts in Burlington County: the 1st, 2nd, and 3rd. There are 137 audit units for the 1st Congressional District and therefore 3 batches were audited. There are 19 audit units for the 2nd Congressional District and therefore 2 batches were audited. There are 2,686 batches in the 3rd Congressional District and therefore 55 batches were audited.

As provided for in the statute, the following audit units were randomly selected for audit on Monday, November 30, 2020 at 10:00 am via a publicly advertised and accessible zoom meeting:

In each district, except Burlington Township, Batch 24, the hand to eye audit was 100% consistent with the machine tally. Burlington Township, Batch 24, showed 98 ballots counted but there were 99 ballots in the batch. The audit did not result in a change in the number of votes counted for any candidate. The voting machines do not allow for overvotes. Any paper ballot which contained an overvote for a particular contest recorded it as an overvote, but did not count a vote. Undervotes were recorded by the vote tabulation system and were reconciled during the course of the audit.
