N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

2020 General Election Audit Date: November 30 and December 1, 2020

The Camden County Board of Elections (CC BOE) performed an audit consistent with provisions of N.J.S.A. 19:61-9.

The CC BOE conducted a hand-to-eye count of the voter-verifiable paper records for the General Election for the U.S. President, U.S. Senator, House of Representatives, and County Board of Freeholders unexpired term. There were no mayoral races in Camden County. The County Surrogate, County Board of Freeholders, municipal races, Board of Education elections, and public questions were excluded from the audit as instructed by the NJ Secretary of State.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." Camden County is comprised of two congressional districts. One hundred and twelve units were chosen from Congressional District One and four units were chosen from Congressional District Two.

Audit units included: vote by mail ballots by municipality/ward: vote by mail received by November 10, 2020 with a timely postmark; provisional ballots by municipality/ward. Tally sheets were prepared in advance of the audit for each municipality/ward and approved by the NJ Division of Elections.

The randomly selected audit units are listed on the attached spreadsheet.

The audit units containing discrepancies are listed below, along with an explanation of the discrepancy. Any paper ballot which contained an overvote for a contest was recorded as an overvote but did not count any votes. The audit did not tally undervotes. The ballot scanners where set to count any circle that was colored in at 35% or more. If 12% to 34% was filled in, the machine finds that mark to be ambiguous, therefore it was sent to adjudication computers for the final decision on voter intent. In Congressional District 2 the audit did not result in a change in the number of votes counted for any candidate.

Congressional District 1

Unit 1-918 - For the hand count a vote for Presidential Candidate Biden was not counted because there was also a circle colored in for a write in, but no name written in. The machine took this as an overvote but in adjudication the write in was voided and a vote given to Presidential Candidate Biden.

<u>Unit 4-769</u> — The Dominion ICC Scanner counted 124 ballots, but the hand count resulted in a count of 128 ballots. This caused a discrepancy in the total vote count. In the hand count, 2 additional votes were counted for Presidential Candidate Biden, 2 additional votes were counted for U.S. Senate Candidate Booker, 2 additional votes were counted for House of Representatives Candidate Norcross, and 3 additional votes were counted for Freeholder Candidate Dyer. Upon further investigation, we believe the difference between the total number of ballots counted in the scanner and the total number of ballots in the hand-count is the result of human error while operating the scanner. There was a failure to double-check the number of ballots in the batch.

<u>Unit 6-292</u> – A additional vote was counted in the hand count over the machine count for House of Representatives Candidate Gustafson. The scanner did not read the vote because the mark was below the 12% threshold.

<u>Unit P2-10</u> - The Dominion ICC Scanner counted 51 ballots, but the hand-count resulted in a count of 49 ballots. This caused a discrepancy in the total vote count. The Presidential machine count is 23 votes for Trump and 26 votes for Biden, while the hand count is 21 votes for Trump and 25 votes for Biden. The U.S. Senate machine count is 22 for Mehta and 28 for Booker, while the hand count is 21 for Mehta and 26 for Booker. The House of Representatives machine count is 23 for Gustafson and 25 for Norcross, while the hand count is 22 for Gustafson and 23 for Norcross. The Freeholder machine count is 25 for Nance and 22 for Dyer, while the hand count is 23 for Nance and 21 for Dyer. Upon further investigation, we believe the difference between the total number of ballots counted in the scanner and the total number of ballots in the hand-count is the result of human error while operating the scanner. There was a failure to double-check the number of ballots in the batch.

<u>Unit P3-36</u> - A additional vote was counted in the hand count for US Senate Candidate Booker and an additional vote was counted in the hand count for House of Representatives Candidate Norcross. The scanner did not read the vote because the mark was below the 12% threshold.

<u>Unit P4-23</u> – A additional vote was counted in the hand count for US Senate Candidate Booker. The scanner did not read the vote because the mark was below the 12% threshold.

<u>Unit P6-36</u> – A additional vote was counted in the hand count for Presidential Candidate Trump. The scanner did not read the vote because the mark was below the 12% threshold.
