N.J.S.A 19:61-9 AUDITS OF ELECTION RESULTS 2020 General Election Audit Date: December 2, 2020

The Morris County Board of Elections performed an audit consistent with the provisions of N.J.S.A 19:61-9.

The General Election held on November 3, 2020 was conducted as an all Vote-by-Mail paper ballot Election per Executive Order 144. Current voting machines used in the County of Morris do not have a voter verified paper audit trail and are exempt from audit.

Pursuant to the statute and Executive Order 144, a random selection of 2% of the paper ballot batches for each Congressional District within Morris County were to be audited. Morris County is comprised of the 7th and 11th Congressional Districts.

The Morris County Board of Elections conducted a hand-to-eye count of the paper ballots for the 2020 General Election for the following offices: President, US Senate, House of Representatives, State Senate, General Assembly, County Freeholder and Local Mayor.

The audit units selected consisted of Vote-by-Mail and Provisional Ballots for the specified Municipality and/or ward and were in in quantities of approximately 100 ballots. Based on the number of ballots returned and number of batches created; 15 batches represent the 2% for the 7th Congressional District and 47 batches represent the 2% for the 11th Congressional District. Attached is a spreadsheet of the audit units drawn for each Congressional District.

In each of the Batches/Units, the hand to eye audit was 100% consistent with the tally reports generated for each of the Batches/Units listed, with the exception of the following:

7th Congressional District -

#5 Chester Twp. (2-1005): Biden/Harris lost (1) vote and Trump/Pence gained (1) vote; Booker gained (1) vote; Malinowski lost (1) vote and Kean gain (1) vote; Rupande Mehta lost (1) vote and Bucco gained (1) vote; Draeger lost (1) vote and Dunn gained (1) vote.

#12 Mount Olive (1-202): Rikin Mehta gained (1) vote.

11th Congressional District -

#5 Denville (2-847): Biden/Harris gained (1) vote; Booker gained (1) vote; Sherrill gained (1) vote; Bucco gained (1) vote

#9 Lincoln Park Ward 2 (1-1416): Rikin Mehta gained (1) vote; Sherrill gained (1) vote; Amaro gained (1) vote.

#10 Lincoln Park Ward 4 (1-624): Trump/Pence gained (1) vote; Booker gained (1) vote; Amaro gained (1) vote.

#17 Montville (2-418): Biden/Harris gained (1) vote; Booker gained (1) vote;

#18 Morris Township (1-293): Trump/Pence gained (1) vote; Booker gained (2) votes;

#20 Butler (1-295): Biden/Harris gained (1) vote; Booker lost (1) vote.

#23 Lincoln Park Ward 4 (4-31): Trump/Pence gained (1) vote; Hoffman gained (1) vote; Becchi gained (1) vote.

Any paper ballot which contained an over-vote for a contest was recorded as an over-vote and did not count. The audit did not tally under-votes.
