## N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

November 2, 2020 General Election Audit Date: November 22, 2021

The Burlington County Board of Elections performed a post-election audit consistent with the provisions of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Monday, November 22, 2021. The audit was open to the public and our Board was present.

The Burlington County Board of Elections conducted a hand-to-eye count for the November 2, 2021 General Election for the offices of the Governor, State Senate, General Assembly, Burlington County Surrogate, and Municipal Council/Committee. In accordance with the law, Public Questions, School Elections, and Fire District Elections were not audited.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." The guidelines provided for this audit require 2% of the audit units in each of the legislative districts to be randomly selected. Audit units included: early voting ballots, vote-by-mail ballots, and provisional ballots. In total, 535 audit units were created.

There are five legislative districts in Burlington County: the 6<sup>th</sup>, 7th, 8<sup>th</sup>, 9<sup>th</sup>, and 12<sup>th</sup>. There are 16 audit units for the 6<sup>th</sup> Legislative District and 2 batches were audited. There are 285 audit units for the 7<sup>th</sup> Legislative District and 6 batches were audited. There are 203 audit units for the 8<sup>th</sup> Legislative District and 4 batches were audited. There are 18 audit units for the 9<sup>th</sup> Legislative District and 2 batches were audited. There are 25 audit units for the 12<sup>th</sup> Legislative District and 2 batches were audited.

In each district, except for two batches, Westampton batch 56 and Maple Shade batch 66, the hand to eye audit was 100% consistent with the machine tally. Westampton batch 56 and Maple Shade batch 66 each had one ballot where the voter completed their ballot in pencil and not all selections were detected.
