N.J.S.A. 19:61-9: AUDIT OF ELECTION RESULTS

2021 General Election Audit Date: November 22, 2021

The Camden County Board of Elections (CC BOE) performed an audit consistent with provisions of N.J.S.A. 19:61-9.

The Camden County Board of Elections conducted a hand-to-eye count of the voter-verifiable paper records for the General Election for Governor, State Senator, General Assembly, County Board of Commissioners, and one municipal race, where available. The County Sheriff, additional municipal races, Board of Education, and public questions were excluded from the audit.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." Camden County is comprised of four legislative districts. Four units were chosen from Legislative District Four, five units were chosen from Legislative District Five, sixteen units were chosen from Legislative District Six, and two units were chosen from Legislative District Eight.

Audit units included vote by mail ballots by municipality/ward and received by November 8, 2021 with a timely postmark; provisional ballots by municipality/ward, and votes cast during Early Voting on voting machines with a paper trail. Tally sheets were prepared in advance of the audit for each municipality/ward.

The selected audit units are listed on the attached spreadsheet.

The audit units containing discrepancies are listed below, along with an explanation of the discrepancy. Any paper ballot which contained an overvote for a contest was recorded as an overvote but did not count any votes. The audit did not tally undervotes. The ballot scanners where set to count any circle that was colored in at 35% or more. If 12% to 25% was filled in, the machine finds that mark to be ambiguous, therefore it was sent to adjudication computers for the final decision on voter intent.

Legislative District 4

Unit 4-29 - For the hand count an additional vote was given to Winslow Ward 2 Township Committee Candidate Carlos A. Viscos. The machine did not see this vote because the check mark went around the outside of the oval. With no mark inside the oval this vote did not meet the threshold for adjudication.

Legislative District 5

<u>Unit 1-122</u> - For the hand count, votes were given to General Assembly Candidates William F. Moen, Jr. and William W. Spearman. There was also a small mark in the oval for Sean Sepsey. This mark would have caused the machine to read this race as an overvote, but the hand counters disregarded that mark and counted that race.

Legislative District 6

<u>Unit 3-261</u> - The machine read 51 ballots in this unit but there are only 50 ballots. We believe that one ballot was inadvertently counted 2 times. This resulted in an additional vote for Governor Candidate Jack Ciattarelli, State Senate Candidate James Beach, General Assembly Candidate Richard Super, County Commissioner Candidates Johanna Scheets, Jennifer Moore, and Rachel Boberg, and Council Candidates David Fleisher, Rossana Parsons, and Diane C. Carr.

<u>Unit 3-261</u> - For the hand count, votes were given to Governor Candidate Philip Murphy, State Senate Candidates James Beach, Louis D. Greenwald, and Pamela R. Lampitt, County Commissioner Candidates Jeffrey L. Nash, Melinda Kane, Almar Dyer and Nicole Roberts, as well as Township Committee Candidates Jessica Rafeh and Marco DiBattista. All votes on this ballot were marked with hand drawn circles to the left of the candidate's names. With no mark inside the actual oval these votes did not meet the threshold for adjudication.

<u>Unit 5-16</u> - For the hand count, an additional vote was given to Governor Candidate Philip Murphy. The machine did not see this vote because the check mark went around the outside of the oval. With no mark inside the oval this vote did not meet the threshold for adjudication.
