NJSA 19:61-9: AUDITS OF ELECTION RESULTS

November 8, 2022 Audit Date: November 23<sup>rd</sup> & 24<sup>th</sup> 2022

The Hudson County Board of Elections (HC BOE) performed a post-election audit consistent with the provision of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Wednesday November 22<sup>nd</sup> and Thursday November 23, 2022.

The HC BOE conducted a hand-to-eye count of the voter-verifiable paper records for the November 8, 2022 General Election for the offices of the US Congress, Sheriff, County Clerk and Local Offices where applicable.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot."

Audit units included: vote by mail ballots by municipality/ward, provisional ballots by municipality/ward, and early voting paper ballots. In total 2,140 audit units were created. Forty-two batches were audited.

There are three Congressional Districts in Hudson County: the 8th, 9th, and 10th.

As provided for in the statute, the following audit units were randomly selected for audit on Tuesday November 22, 2022 at 10:00am:
