AUDIT OF ELECTION RESULTS 2023 GENERAL ELECTION AUDIT DATE: November 20, 2023

In accordance with N.J.S.A. 19:61-9c(5), the Essex County Board of Elections divided all Vote by Mail, Provisional, Early Voting Ballots and ICP Official Ballots into "batches/audit units" and then sorted by Congressional Districts. Two percent (2%) of the number of batches in each of the Essex County Legislative Districts 27, 28, 29, 34 and 40 were randomly selected to audit. Our audit consisted of a total of 49 batches: 27th Legislative District 13 batches, 28th Legislative District 11 batches, 29th Legislative District 7 batches, 34th Legislative District 14 batches and the 40th Legislative District 4 batches.

In each batch, a hand to eye audit was completed. Attached is a complete breakdown of the batches selected for audit.
