N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS November 5, 2024 General Election and Audit Date: November 20 & November 21, 2024

The Burlington County Board of Elections performed a post-election audit consistent with the provisions of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Monday & Tuesday, November 20 & 21, 2024. The audit was open to the public and our Board was present.

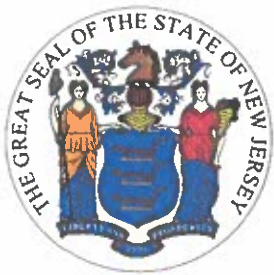
The Burlington County Board of Elections conducted a hand-to-eye count for the November 5, 2024 General Election for the offices of U.S. President, U.S. Senate, U.S House of Representatives, County Commissioners, & Municipal Mayor or Council/Committee in all batches selected. In accordance with the law, Public Questions, School Elections, and Fire District Elections were not audited.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." The guidelines provided for this audit require 2% of the audit units in each of the congressional districts to be randomly selected. Audit units included: early voting ballots, vote-by-mail ballots, election day and provisional ballots. In total, 1015 audit units were created.

There are two Congressional Districts in Burlington County: The First and Third. There were 56 audit units for the 1st Congressional District and 2 batches were audited. There are 959 audit units for the 3rd Congressional District and 20 batches were audited.

In 19 of the 22 audit batches, there was a 100% consistency to the machine tally. In 3 of the largest audit batches, although not 100% accuracy, the error rate was 1% or less.

We also had a pilot audit with Clear Ballot using their automatic auditing system. It was extremely successful. It took 8 teams of 4 people counting from 8:30 am to 5 pm, 2 days to complete the audit. A batch of 100 ballots would take a good team approx. 1 hr to count. The Clear Ballot audit system did that same batch with 100% accuracy in 2 minutes. The largest batch (Early Voting ballots) with 3640 ballots was done with 100% accuracy in less than an hour.
