N.J.S.A. 19:61-9 AUDITS OF ELECTION RESULTS

November 5, 2024 GENERAL ELECTION

Audit Date: November 18, 2024

The Passaic County Board of Elections performed an audit consistent with the provisions of N.J.S.A. 19:61-9.

The General Election held November 5, 2024 was conducted using Vote-by-Mail, Provisional and Voting Machines ballots. Current voting machines in the County of Passaic do have a verified voter paper trail. Pursuant to the statute, if fewer than 100 election districts are within the Congressional district, two batches/audit units were to be selected for audit. If the Congressional district has 100 or more election districts within the Congressional district, then 2% of the batches/audit units in that Congressional District are to be audited. Passaic County is comprised of 3 Congressional Districts. Congressional Districts 05, 09 and 11.

On November 18, 2024, the County of Passaic Board of Elections conducted a hand-to-eye count of the paper records for the General Election held November 5, 2024 for the following offices: President/Vice President, US Senate, Congress, Sheriff and Mayor or Municipal Council where applicable.

Audit units were comprised of vote-by-mail ballots, provisional ballots and Voting Machines. 11 batches in total were audited.

The following batches were randomly selected for the audit:

In each audit batch, the hand to eye audit was 100% consistent with the tally reports generated for each of the above listed batches except for one identified above with an asterisk.

The Audit Results for Totowa Mail-In Batch B0040 are listed below. These audit results were confirmed by four hand-to-eye counts of the ballots and a rescan of the ballots through the ES&S system. Without speculating, the Board has not identified the cause of the difference in the initial scanned results of this batch.
