The mandatory pre-proposal meeting/site visit is scheduled for **Tuesday, June 23, 2026, at 10:00 AM**. Consultants shall meet at the Northern State Prison – 168 Frontage Road – Newark, NJ 07114. (Rain or Shine.) Only those firms attending the mandatory pre-proposal meeting will be permitted to submit a proposal. **Please note that electronic devices such as smart watches, fit bits, cell phones and cameras are prohibited. Consultants are also not to wear any khaki colored clothing.**

Technical Proposals will be evaluated by the Selection Committee based upon the following evaluation criteria:

1. Firm/Team Organization/Sub-Consultants
2. Experience of the Firm, Project Team and Key Team Members
3. Project Approach/Understanding of Project
4. The Firm's Approach to Maintaining the Project Schedule

Pursuant to N.J.A.C. 17:13-1.1 et. seq., this project has been designated as a **Small Business Set-Aside Opportunity**.
